IMPORTS FROM CHINA

2781(H). SHRI VISHAMBHAR PRASAD NISHAD: CH. SUKHRAM SINGH YADAV: SMT_CHHAYA_VERMA

Will the Minister of **COMMERCE AND INDUSTRY** be pleased to state:

- (a) whether the imports from China, which had stopped at the time of Corona pandemic outbreak, have regained their momentum now;
- (b) the details of goods which are being imported from China again after Corona pandemic, along with the quantum of imports;
- (c) the details of Chinese companies which have succeeded in getting contracts and new assignments in the wake of post Corona scenario;
- (d) the Chinese Apps which have been banned by Government along with the details of escape routes being adopted by China to avoid those sanctions; and
- (e) details of Indian goods being exported to China in post Corona pandemic?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI HARDEEP SINGH PURI)

(a) to(e): The Corona Virus outbreak in China reportedly impacted some Indian industries which are dependent on China for import of components, intermediaries and raw materials, at the outset of the pandemic in China. Chinese production has resumed during the year. The products imported from China include electronic goods, machinery, fertilizers, textile/yarn fabric, leather & leather products, organic chemicals etc. The details of goods imported from China may be seen at **Annexure-I.**

The Government has made certain changes in its FDI policy and General Financial Rules 2017, to safeguard its national security and other interests in the wake of the Covid scenario.

Now, any entity, situated in or whose citizen belongs to any land border sharing country with beneficial ownership, can bring investment or participate in any Government contract only with prior Government approval alone. Till date, five proposals have been approved under the above mechanism.

Government has blocked approximately 293 mobile applications under the provisions of section 69A of Information Technology Act 2000 in the interest of sovereignty and integrity of India, security of the State and defence of India.

The Indian goods exported to China include marine products, iron ore, organic & inorganic chemicals, engineering goods, electronic goods, spices, petroleum products, cotton yarn etc. The details of goods exported to China may be seen at **Annexure-II**.
